CENTRE FOR DENTAL STUDIES

TAFE SA Centre for Dental Studies provides career pathways with courses in dental assisting, dental radiography, dental technology and dental hygiene.

Our dental studies programs are nationally endorsed and the Advanced Diploma of Oral Health (Dental Hygiene) (10926NAT) is accredited by the Australian Dental Council (ADC) providing evidence of consultation with learners, industry and community towards provision of quality assured and industry supported programs of learning.

Dental studies programs incorporate innovative and flexible learning and assessment methodologies to reflect current practice within the dental community and industry. An emphasis on integrating current evidence-based science and practice is facilitated through scaffolded competency based learning that reflects required knowledge and skills for industry application.

The innovative methodologies include the online learning management system that facilitates a virtual environment for all learners to access valuable learning and assessment resource to support their learning endeavours.

FACILITIES

The Centre for Dental Studies at TAFE SA Gilles Plains is a modern teaching facility for dental studies including an updated 36 station dental laboratory and a state-of-the-art 28 chair, fully functioning dental clinic and demonstration area, with intraoral and extraoral cameras. The clinic also includes 7 intraoral radiography units, and a panoramic radiography machine.

Students will also attend the University of Adelaide's Dental Simulation Clinic, located in the city's North Terrace campus. The simulation clinic has 90 individual simulators, each equipped with their own dental manikin simulator, dental equipment, computer and monitor.



COURSE AIM AND OBJECTIVES

The Advanced Diploma of Oral Health (Dental Hygiene) (10926NAT) is designed to provide learners with the skills and knowledge on graduation to apply to the Australian Health Practitioner Regulation Agency (AHPRA) to work as dental hygienists in both private and government sectors. This is in accordance with the legislative provisions, and contemporary dental hygiene practice and theory.

The course has a focus on oral health, and aligns with the Dental Board of Australia's scope of practice of a dental hygienist, to provide services for all ages in:

- > assessment
- > diagnosis
- > treatment
- > management
- > education to prevent oral disease
- > promotion of healthy oral behaviours.

This may include periodontal and gingival treatment, preventative services and other oral care.

Each graduate will have developed the knowledge, skills, behaviours, attitudes, values and judgements that will enable them to:

- > provide preventive and therapeutic oral health care at team, individual and community level
- > work effectively in partnership with other allied health professionals to encourage the adoption of optimum oral health practices by the individual and/or community group
- > design, conduct and evaluate health promotion on links between general and oral health to individuals, at team, individual and community level
- > collect, analyse and interpret data for the individual patient and/or community group/s, to design, implement and evaluate strategies that:
 - addresses hygiene treatment and preventive oral health needs at individual and community level
 - collaborates with patient groups and other dental and health care professionals

- > maintain the highest level of professionalism in the practice of dental hygiene through:
 - the use of accountable and sustainable care management strategies
 - the adoption of reflective work practices and relevant lifelong learning
 - the identification and completion of professional development requirements
 - the provision of ethical patient care
- > provide leadership and mentoring in developing and promoting effective, professional and accountable work practices that are evidence-based and quality assured
- > monitor and evaluate treatment outcomes as a means of providing responsive dental hygiene practice.

COURSE OUTLINE

The TAFE SA Advanced Diploma of Oral Health (10926NAT) is the only professional oral health advanced diploma available in South Australia. Students work and study as part of a small oral health community in a supportive and collegial manner. Key features of the program include early clinical experience, a significant amount and variety of clinical practice, health promotion and development of research skills.

The program focuses on developing students' competence in:

- > clinical examination and diagnosis of oral disease
- > formulation of individual treatment plans for patients
- > prevention and control of oral disease by clinical treatment and preventative procedures
- > health promotion to clients and the community to establish patterns of behaviour conducive to good oral health.

Graduates of the program strive through their advocacy and clinical practice to empower individuals and communities to maintain optimum oral health throughout their lives.

COURSE DELIVERY

The course is delivered in a combination of simulated practice, competency based and problem-based learning. Students gain supervised clinical experience in the TAFE SA Dental Clinic, and in other specialist clinical areas throughout the course.

COURSE LENGTH

The Advanced Diploma of Oral Health (Dental Hygiene) (10926NAT) takes two years full-time or part-time equivalent to complete. Face-to-face contact is a minimum of 24-30 hours a week (3-4 days a week), which includes simulation, and clinic placements.

COURSE ADMISSION REQUIREMENTS

Course entry requirements include the following.

ESSENTIAL ENTRY REQUIREMENTS

- > Certificate III in Dental Assisting (HLT35015) or higher qualification in a health or dental field

OR

- > Completion of the South Australian Certificate of Education (SACE) or equivalent.

All applicants are required to undertake Dental Hygiene Admission testing. Details of the testing are available on the TAFE SA website under the qualification code.

RECOMMENDED ENTRY REQUIREMENTS

Successful students who do not already hold a licence to operate an ionising radiation apparatus will need to enrol in the following units within the first year of their studies:

- > Apply the principles of radiation biology and protection in dental practice (HLTDEN007)
- > Prepare to expose a prescribed dental radiographic image (HLTDEN008)
- > Produce a prescribed dental radiographic image (HLTDEN009).

(or replacement codes if superseded).

All students must have a current Australian First Aid Certificate prior to commencing their supervised clinical practice and are required to maintain a current certificate throughout the length of the studies in the program.

Prior to enrolment, candidates will be advised that to undertake the course they must be eligible for unlimited registration as a student with the Dental Board of Australia under the *Health Practitioner Regulation National Law Act 2009*.

Many health care facilities including those operated by SA Health, require candidates and other health care workers to present the result of a Criminal History Check, and evidence related to immune status to vaccine preventable diseases, blood borne virus infection, and tuberculosis screening, prior to allowing clinical access to patients. Failure to comply with any of the above requirements is likely to result in being unable to undertake the clinical placements necessary for completion of this course.

All clinical subjects are taught at the TAFE SA Dental Clinic located at Gilles Plains, and at the University of Adelaide's Dental Simulation Clinic, in the Adelaide CBD.

ASSESSMENTS

Dental studies topics incorporate innovative and flexible learning and assessment methodologies, to reflect current practice within the dental community and industry.

CREDIT TRANSFER

If you have completed equivalent studies, you may apply for credit transfer once you have been accepted into the TAFE SA course.

RECOGNITION OF PRIOR LEARNING

If you have gained the skills and knowledge equivalent to a unit in this course through work experience, life skills or on the job training you may apply for the recognition of these skills, once you have been accepted into the course. This may shorten the length of time required for you to study to complete the course.

FEES

Full fee: \$55,688

Subsidised fee: \$14,625

This course is funded through the Government of South Australia's subsidised initiative. Eligibility criteria apply, incidental fees may apply for specific tools, materials, events or uniforms.

Students will need to check course fees directly with TAFE SA via website TAFE SA Courses. TAFE SA will advise students about all fees and publish their fee policies on TAFE SA website.

Subject to eligibility, only applies to courses that are listed on the subsidised training list.

Applying for a TAFE SA course is free. Concessions will be available for students who:

- > hold a health care card;
- > hold a pensioner concession card; and/or
- > hold a pensioner concession card issued by the Department of Veteran Affairs.

HOW TO APPLY

Entry to the course in South Australia is administered through the South Australian Tertiary Admissions Centre (SATAC). Visit tafesa.edu.au/courses and click on courses listed with 'Apply Now'.

FINANCIAL ASSISTANCE

Students are able to apply for a VET Student Loan for TAFE SA diploma and advanced diploma qualifications.

VET Student Loans are a Commonwealth Government loan scheme which assists students to pay for all or part of the TAFE SA tuition fees. Like HECS, it is an income contingent loan. A VET Student Loan will be repaid through the Australian taxation system once your repayment income is above the minimum threshold.

To be eligible for VET Student Loan assistance, you must be:

- > a student of any age
- > an Australian citizen; or
- > the holder of a permanent humanitarian visa and resident in Australia for the duration of the TAFE unit of study
- > studying with an approved VET training provider.

STUDENT ELIGIBILITY

Student eligibility applies to all new students or ongoing students commencing a new course. Students will be eligible for subsidised training if they meet all three (only two are listed) student eligibility criteria at the time of enrolment, and a place is available.

1. AGE

The individual is aged 16 years or over.

2. RESIDENCY STATUS

The individual either resides or works in South Australia – as determined by postcode of home address or place of work; and

- > is an Australian or New Zealand citizen; or
- > is a permanent Australian resident; or
- > holds a state sponsored visa on a pathway to permanent residency.

SUPPORT SERVICES

General career and education counselling and learning support are available. Most campuses have a learning resource centre (library), student lounge and recreational activities.
